



GENERAL TERMS AND CONDITIONS OF CONTRACT

1. INTRODUCTION

The purpose of this document is to regulate the GENERAL TERMS or CONDITIONS of CONTRACTING of the services of Pre - online reservation (hereinafter Pre - online reservation, or services) of DAESBO, SL, operating company of CAMPING PLATJA CAMBRILS, with registered office in the town Cambrils (Tarragona), more specifically in Av. Oleatrum, 43,850 constituted by public deed. Registration data in the Mercantile Registry of Barcelona: Volume 24334, folio 167, sheet B26973, 25th registration and administrative authorization RDGTKT-0077-46, being the competent body of supervisor the activity the Tourist Administration of the Generalitat.

The Terms "You" and "User" are used here to refer to all individuals and / or entities that for any reason access <https://www.playacambrils.com/> or use the services.

The use of these services will imply full and unreserved acceptance and validity of each and every one of the General Terms and / or Conditions -which will be considered automatically incorporated into the contract signed with DAESBO, SL, without its written transcript is necessary in it - collected in the latest updated version of these General Terms and / or Conditions.

2. USE OF THE PRE-RESERVATION SERVICES ON-LINE DE DAESBO, S.L.

2.1. Pre - online booking services

a. The Pre - online reservation services are intended to pre - reserve a plot / s or a bungalow / s in CAMPING PLATJA CAMBRILS. The use of these services will imply full and unreserved acceptance, and validity, of all and each of the General Terms and / or Conditions -which will be considered automatically incorporated into the contract signed with DAESBO, SL, without the need for a written transcript in it - included in the latest updated version of these General Terms and / or Conditions.

b. Contracting procedure: When using the service, the user will choose the dates in which he wants to hire the plot (s) or the bungalow / s. If there is availability, the user can click on the "RESERVE" button, then enter the number of people, vehicles and other accessories, as well as the introduction of a coupon code and the comments that the user wants effect for that purpose. Finally, the user will enter the contact information (name, surname, date of birth, address, zip code, city, country, email, contact phone number, contact phone number, fax number, ID number), as well as the name and surname of the occupant / occupants, and the date of birth thereof. It will then be transferred to a payment gateway, and after its payment, the contract will be deemed perfected.

The user, once the payment has been made, will be transferred to a web page where he can check the pre-reservation request, the data of the same and the possibility of printing said document. Likewise, a confirmation email of the pre - reservation is sent to the email expressed by the user. In turn, you will be granted a locator number for the pre - reservation, which can be entered in the "FOLLOW-UP OF THE PRE-RESERVATION" section found at

C. Guarantee: The pre - reservation is confirmed and guaranteed during the first night and until 20:00 hours UTC + 1 Europe / Madrid the next day. In case of no-show, there will be no refund of the amounts paid as a pre-reservation (VAT and fees included).

d. Termination of the contract or cancellation of the pre - reservation: The credit card is only a means of guarantee. The cancellation of reservations by the user will not incur the cost of early cancellation, provided that the following conditions are met:

- The cancellation of Bungalow is notified to CAMPING PLATJA CAMBRILS with a notice of 30 days before arrival, taking the 00:00 hours UTC + 1 Euro-pa / Madrid as the deadline to perform it.

- The cancellation of Camping is notified to CAMPING PLATJA CAMBRILS with a notice of 15 days before arrival, taking the 00:00 hours UTC + 1 Euro-pa / Madrid as the deadline for the same

In any case, if the user notifies the cancellation with a notice of less than 6 days before arrival, taking the 00:00 hours UTC + 1 Europe / Madrid as the deadline to carry out the same, the amount will not be refunded Someone to the user.

This clause is not valid for reservations made with special rates. In this case, the respective conditions established will apply.

The limit hours of arrival at the campsite in each country are:

- Spain: 00:00 hours UTC + 1 Europe / Madrid on the day of arrival

In any case, circulation with motor vehicles is prohibited r within the camping facilities from 00:00 hours UTC + 1 Europe / Madrid. Therefore, the car must be parked outside the premises, the traffic being reopened after 8:00 am. and. Policies for children CAMPING PLATJA CAMBRILS

Policies for children in CAMPING PLATJA CAMBRILS are subject to the facilities and determined by the CAMPING PLATJA CAMBRILS management, as described in the current contracts. In any case, children under 2 years of age will not be considered clients, in the sense that they will not be charged for their stay.

F. Children Policy

Children under 18 must stay at CAMPING PLATJA CAMBRILS accompanied by their parents, guardians or adults duly authorized by them. CAMPING PLATJA CAMBRILS staff may require relevant documentation that identifies adults as their parents / guardians or authorized persons.

g. Animal policy

Pets are welcome at CAMPING PLATJA CAMBRILS only on the plot (s) with an additional charge and subject to the presentation of vaccination and fitness certificates for the possession of categorized dogs. If dogs are included in the list of dangerous animals, they must comply with the safety measures established for these animals.



It is strictly forbidden to access animals to the bungalow area or inside the bungalows themselves.

h. Prices per plot, bungalow / s and night.

The prices are only valid in writing and during the period indicated in them. When there are justifiable reasons, DAESBO, S.L. The right to modify these rates is pre-reserved without prior notice.

The prices related to the pre - reservation will be indicated during the pre - reservation process. VAT is applied to prices, notwithstanding that additional taxes are also applied according to local regulations in force in Spain. The aforementioned local taxes must be paid directly at CAMPING PLATJA CAMBRILS.

i. The prices shown at the time of the pre - reservation include VAT according to the tax rate applicable at the time.

In the event that the tax rate changes between the date of the pre - reservation and the date of delivery of the services, generating a disparity, according to the tax regulations, the tax rate that will be applied to the final price will be the one that corresponds at the time of delivery of the services or the accumulation of the tax, even in cases where this would cause an increase in relation to the final price indicated to the client during the pre - reservation.

2.3 The user undertakes to use the services in accordance with the Law, morality, good customs and public order, as well as with the provisions of these General Terms and / or Contract Conditions. Consequently, it is obliged not to use the services, for purposes or effects that are unlawful and / or contrary to what is established in these General Terms and / or Conditions for contracting, which are harmful to the rights and / or interests of third parties or that, of Any way, they can damage the services, DAESBO, SL and / or its image.

2.4 DAESBO, S.L. may, for greater agility and for the benefit of the users, unilaterally modify, at any time and without prior notice, the services provided, or the conditions of operation, techniques and use of the services. 4. EXCLUSION OF GUARANTEES AND LIABILITY

4.1 If DAESBO, SL, despite acting with due foresight and due diligence, can not facilitate the plot (s) or bungalow / s hired for reasons that are not attributable to it and if there is an impossibility to provide services in the agreed conditions, DAESBO, SL It will offer the user the possibility of opting for the total reimbursement of the subscriber or for replacing it with another one with similar characteristics as regards its category or quality. If the service is inferior to the category or quality of the replacement, DAESBO, S.L. will refund the difference.



5. SAFEGUARD OF THE TERMS AND / OR GENERAL CONTRACT CONDITIONS

If one of the stipulations of these General Terms and / or Contract Conditions is declared void or inoperative, the rest of the General Terms or Conditions will remain in the agreed terms. DAESBO, S.L. They undertake to replace the stipulation affected by the nullity as close as possible to the intention initially pursued by the parties.

No stipulation in this contract will affect in any way the mandatory stipulations regarding consumers and users. If you are not a consumer, you expressly waive your right of withdrawal.

6. WWW.PLATJACAMBRILS.COM AND ACCEPTANCE OF USE RULES

The user is aware that the use of the services of the Pre - reservation services on-line implies full and unreserved acceptance of each of the clauses that are part of the Rules of Use of www.platjacambriils.com, in the publi-cada version by DAESBO, SL at the moment when the user contracts the service. These rules of use complete these General Terms or Conditions in everything that they do not oppose. Therefore, the user must be aware of the importance of consulting the rules of this page, prior to accessing and / or using this services.

7. APPLICABLE LAW AND COMPETENT JURISDICTION

In all cases, any dispute that arises from the provision of services in the campsite in which the client is staying will be submitted to the consumer's courts.
