



## **PRIVACY POLICY**

### **Who is responsible for the processing of your personal data?**

We inform you that the personal data that you have provided us will be treated as responsible for processing by DAESBO, S.L., with address at, Av. Oleastrum, 43850 Cambrils, Tarragona, telephone 977361490 and email [info@platjacambrils.com](mailto:info@platjacambrils.com)

### **For what purpose do we treat your personal data?**

The purpose of the treatment will be to respond to inquiries that you as a user can make us, as well as to send you advertising related to the services we provide in case you give your consent, specifically, the provision of tourist accommodation services.

### **What is the legal basis of the processing of your personal data?**

The granting of consent on your part.

Who will we provide your personal data?

Your personal data will not be transferred to third parties, nor will we make international transfers thereof without your prior consent.

### **How long will we keep your personal data?**

The data will be kept for the duration of the purpose for which you have provided them, once the same has been fulfilled, the personal data will be kept, duly blocked, according to what is established by current sector regulations.

### **What are your rights as the owner of your personal data?**

You have the right to request access, rectification of your incorrect or inaccurate personal data, portability, and deletion of your personal data, among other reasons, when the data is no longer necessary for the purposes for which it was collected.

You can also request in certain situations, the limitation of the processing of your personal data, keeping them only for the exercise or defense of claims.

You may also object to the processing of your personal data, in certain circumstances and for reasons related to your particular situation.

In accordance with the provisions of Art. 7.3 GDPR, you have the right to withdraw the consent given at any time, without the withdrawal of consent affecting the legality of the treatment carried out before the withdrawal thereof. You are informed that, if you exercise this right, you will not be able to provide the requested information, or proceed to send commercial communications.

You have the right to file a claim with the control authority before the Spanish Agency for Data Protection if you believe that your rights may have been violated in relation to the protection of your data ([agpd.es](http://agpd.es)).

### **Mandatory**

### **Principles of treatment**

The personal data provided by the user are treated in accordance with the provisions of Art. 5 and 6 of the GDPR, in a lawful and transparent manner, collected for the purposes specified above, being the same legitimate, and will not be treated further in a manner incompatible with these purposes. Likewise, confidentiality is guaranteed in their treatment.

In addition, the data collected are adequate, relevant and limited in relation to the purposes for which they are processed.

Veracity and accuracy of the user's personal data

The user guarantees that the information provided is true, accurate and correct, and undertakes to communicate any changes that may occur in them in order to comply with the principle of accuracy of personal data established by the GDPR.

### **Security measures**
